

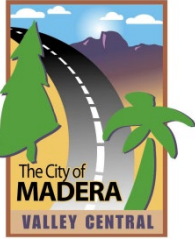

### SUBJECT:

Filling of Councilmember Vacancy in City Council District 5

### RECOMMENDATION:

This recommendation is based on City Council (Council) direction at the Special Meeting of January 25, 2021, and a request from Mayor Garcia to add further discussion and consideration of an appointment to this Special Meeting agenda.

The recommendation is that the Council fill the vacancy by appointment or special election. Council may:

- (i) Select an applicant by motion and adopt the resolution making the appointment OR
- (ii) Adopt the Resolution calling for the Holding of a Special Municipal Election for the Election of Vacancy in City Council District 5

### SUMMARY:

On January 25, 2021, a Special Meeting of the Council was held to proceed with the intent to appoint a person to fill the District 5 vacancy. Three applicants were considered for appointment; one applicant, Christopher Mariscotti, withdrew his application during the selection process. After deliberation and multiple motions, Council was unable to select an appointee to fill the District 5 vacancy. Council then directed staff to present a resolution calling for a Special Election before January 31, 2021. After the January 25, 2021, meeting, Mayor Garcia requested that the Special Meeting agenda include further consideration of an appointment to District 5.

### DISCUSSION:

Per the California Government Code, the Council is required to make an appointment or adopt a resolution calling for a special election before January 31, 2021.

Two resolutions are attached. The first resolution concerns the filling of the vacancy by appointment. The second resolution calls for a Special Municipal Election to be held on Tuesday, November 2, 2021 for the purpose of filling the vacancy in District 5, and that the Madera County Clerk conduct the election as specified by Section 10418 of the Elections Code relating to the election.

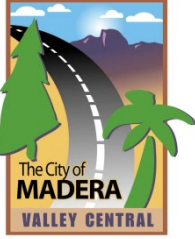
The person appointed or elected will fill the unexpired term which is scheduled to expire in December 2022. Both resolutions require four votes.

**FINANCIAL IMPACT:**

The estimated cost of holding a special election in November 2021 is between \$15,000 and \$20,000.

### **SUBJECT:**

City Council Appointment to Fill Vacancy in Council District 5

### **RECOMMENDATION:**

Consider the applications for the City Council District 5 seat and after selection adopt a Resolution making appointment to fill the vacancy or direct staff to bring a Resolution calling a special election to a special meeting set by the City Council no later than January 31, 2021

### **DISCUSSION:**

On December 2, 2020, the City Council determined to proceed with an appointment to fill the vacancy created by the election of Santos Garcia to the Mayor seat. This mid-term vacancy requires that the Council fill the vacant Council seat by appointment or special election. At its regular Council meeting on December 2, 2020, the Council announced its intent to appoint a person to fill the Council District 5 seat vacated by the election of Santos Garcia to the At-large Mayor seat and authorized the issuance of applications for appointment. While Council decided to pursue the appointment process, the Council could still elect to fill the vacant seat by special election.

The deadline to submit applications for the City Council District 5 vacant seat was Tuesday, January 12, 2021 at 5pm. An invitation to submit applications for appointment were posted in the Madera Tribune and the City's website and social media platforms.

### ***Eligibility:***

It is noted that the City adheres to California legislation and any person that meets the following may apply and be considered:

- a resident of District 5,
- a registered voter, and
- a United States citizen 18 years of age or older.

The City received four applications by the deadline date. One applicant withdrew after it was determined that the applicant lives outside of the Council district.

The three applicants are listed on Table 1 in alphabetical order.

<b>Table 1: Applicants (listed in alphabetical order)</b>

The three applicants meet the required criteria.

**Process:**

During the meeting, it is recommended that eligible applicants may make up to a five-minute presentation to the City Council indicating their qualifications and interest in the position. After all the candidates make their presentation, members of the City Council may ask questions of candidates and members of the public will have an opportunity to comment on the applicants. The Council will then deliberate in open session and proceed to make its selection.

Once presentations by applicants, questions by Council, and public comment are concluded, the Council will proceed with selection. The Council may:

1. Motion and second to make an appointment
2. Deliberations
3. If the motion receives four affirmative votes, proceed to adopt the resolution making the appointment
4. If the motion does not receive four affirmative votes, entertain another motion and proceed as in section 3 above. If necessary, continue with subsequent motions until an applicant receives four affirmative votes.

If the Council is unable to make a selection or in the event of a tie vote after multiple votes, the Council would need to adopt a resolution calling a special election. In order to meet the language in Elections Code Section 36512 (b) (1) a special election may not occur before the next regularly established election date of November 2, 2021. The result is that the position would remain open for almost a year.

**FINANCIAL IMPACT:**

There is no fiscal impact to fill the vacancy by appointment. The estimated cost of holding a special election in November 2021 is between \$15,000 and \$20,000.

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MADERA TO FILL THE DISTRICT 5 VACANCY ON THE CITY COUNCIL FOLLOWING AN APPLICATION AND INTERVIEW PROCESS**

**WHEREAS**, City Council District 5 Councilmember Santos Garcia was elected to serve as the City's Mayor; and

**WHEREAS**, at a regular meeting of the City Council held on December 2, 2020, the City Council approved Resolution No. 20-163 adopting a process to fill an unscheduled vacancy on the City Council resulting from the election of Santos Garcia to the Mayor seat; and

**WHEREAS**, the application period ended at 5:00 PM on Tuesday, January 12, 2021; and

**WHEREAS**, four applications were received from District 5 residents who expressed their interest in serving on the City Council and their willingness to fulfill the remaining term of the vacated office which will expire in December 2022; and

**WHEREAS**, one applicant withdrew their application because they reside outside of the Council district; and

**WHEREAS**, at their special meeting held on January 25, 2021, the City Council considered the applications, allowed applicants to address the Council, and provided an opportunity for the public to comment upon the applicants.

**NOW, THEREFORE**, the City Council of the City of Madera hereby resolve as follows:

1. Pursuant to Government Code Section 36512, \_\_\_\_\_ is hereby appointed to the vacant District 5 position on the City Council and shall serve as a member of the Madera City Council for the remainder of the unexpired term of former Councilmember Santos Garcia.
2. The person appointed shall take office effective immediately after taking the Oath of Office and shall serve exactly as if elected at a municipal election for the office for a term ending in December 2022.
3. This resolution shall become effective immediately upon adoption.

**WHEREAS**, at a regular meeting of the City Council held on December 2, 2020, the City Council approved Resolution No. 20-163 adopting a process to fill an unscheduled vacancy on the City Council resulting from the election of Santos Garcia to the Mayor seat; and

**WHEREAS**, the application period ended at 5:00 PM on Tuesday, January 12, 2021; and

**WHEREAS**, four applications were received from District 5 residents who expressed their interest in serving on the City Council and their willingness to fulfill the remaining term of the vacated office which will expire in December 2022; and

**WHEREAS**, one applicant withdrew their application because they reside outside of the Council district; and

**WHEREAS**, at their special meeting held on January 25, 2021, the City Council considered the applications, allowed applicants to address the Council, and provided an opportunity for the public to comment upon the applicants but was unable to make an appointment; and

**WHEREAS**, one applicant withdrew their name from consideration during deliberations during the meeting on January 25, 2021; and

**WHEREAS**, the City Council reconsidered an appointment at a special meeting held on January 28, 2021.

**NOW, THEREFORE**, the City Council of the City of Madera hereby resolve as follows:

1. Pursuant to Government Code Section 36512, \_\_\_\_\_ is hereby appointed to the vacant District 5 position on the City Council and shall serve as a member of the Madera City Council for the remainder of the unexpired term of former Councilmember Santos Garcia.
2. The person appointed shall take office effective immediately after taking the Oath of Office and shall serve exactly as if elected at a municipal election for the office for a term ending in December 2022.

3. This resolution shall become effective immediately upon adoption.

CALIFORNIA, CALLING FOR THE HOLDING OF A SPECIAL MUNICIPAL  
ELECTION ON TUESDAY, NOVEMBER 2, 2021, FOR THE ELECTION OF  
VACANCY IN CITY COUNCIL DISTRICT 5**

**WHEREAS**, Councilmember Garcia has been elected as Mayor for the City of Madera resulting in a vacancy for his position as councilmember of District 5; and

**WHEREAS**, under Elections Code 36512 the City Council must fill a vacancy on the City Council within sixty days from the commencement of the vacancy by election or by appointment; and

**WHEREAS**, the City Council has determined to fill the vacancy by the calling of a special election.

**NOW, THEREFORE**, the City Council of the City of Madera hereby resolves as follows:

**Section 1.** Recitals. The foregoing recitals are true and correct and incorporated herein as if set forth in full.

**Section 2.** Calling of Special Election. Pursuant to the requirements of the laws of the State of California relating to general law cities, there is called and ordered to be held in the City of Madera, California, on Tuesday, November 2, 2021 a Special Municipal Election for the purpose of filling the vacancy in City Council District 5.

**Section 3.** Consolidation. Pursuant Section 10400 et seq. of the Elections Code, the Board of Supervisors of Madera County is requested to consolidate the Election with an election that may be held on the established election date of November 2, 2021.

**Section 4.** Canvass. The Board of Supervisors is authorized to canvass the returns of the Election pursuant to Section 10411 of the Elections Code.

**Section 5.** Conduct of Election. Pursuant to Section 10002 of the Elections Code, the Board of Supervisors is requested to permit the County Clerk to render all services specified by Section 10418 of the Elections Code relating to the election, for which services the City agrees to reimburse the County, in accordance with current County pro-rations and allocation procedures. In all particulars not recited in this resolution, the election shall be held and conducted as provided by law for holding municipal elections. Notice of the time and place of holding the election is given and the Elections Official is authorized, instructed, and directed to give further or additional notice of the election, in time, form and manner as required by law.

**Section 6. Filing with County.** The City Clerk shall file a certified copy of this Resolution with the County Clerk.

**Section 7. Implementation.** The City Clerk and City Manager are authorized to take all actions as necessary to effectuate the purposes of this resolution and the election. The City Clerk and City Attorney are authorized to make any typographical, clerical, and non-substantive corrections to this resolution as may be deemed necessary by the Madera County Clerk.

**Section 8. Effective Date.** This Resolution shall be effective immediately upon adoption.
