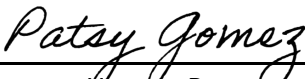

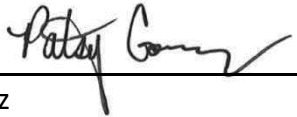
d. #26-25 Police Officer Trainee
