<b>Staff</b>	The objective of the upcoming meeting is to review the previous year CDBG allocation process and performance to incorporate enhancements in the upcoming year. The Advisory Committee will determine what criteria will be used to evaluate previous years' recipients, to assess their merit for future allocations, make a recommendation about the role that Council Members will have in making allocation selections, and plan strategies for developing community engagement activities to determine next year's funding priorities.


