Speakers shall be limited to three minutes. Speakers will be asked to identify themselves and state the subject of their comment. If the subject is an item on the Agenda, the Mayor has the option of asking the speaker to hold the comment until that item is called. Comments on items listed as a Public Hearing on the Agenda should be held until the hearing is opened. The Council is prohibited by law from taking any action on matters discussed that are not on the Agenda, and no adverse conclusions should be drawn if the Council does not respond to public comment at this time.

Luis Ceja spoke on behalf of students of Virginia Lee Rose Elementary and Martin Luther King Middle School about Item C-1. He discussed concerns with student safety during after school hours. Many children are injured or killed when they dart out in front of cars. There needs to be places that are safe for walking. Funding of our proposal will allow for the installation of blinking lights to ensure safe passage for students, bicyclists and pedestrians during heavy road traffic. He requested that council support their community effort to promote awareness to help protect the children from a traffic fatality.

Khalid Chaudry discussed concerns with deficit on golf course, salary raises, item G-3, Council Member Rigby's award, and Pomona Ranch.
