#### **APPROVAL OF AGENDA:**

ON MOTION BY COUNCILMEMBER EVANS AND SECONDED BY COUNCILMEMBER MONTES, THE AGENDA WAS APPROVED BY A VOTE OF 6/0. AYES: MAYOR GARCIA, COUNCILMEMBERS GALLEGOS, RODRIGUEZ, MONTES, EVANS AND VILLEGAS. NOES: NONE. ABSENT: DISTRICT 5 IS CURRENTLY VACANT. ABSTAIN: NONE.

#### **PUBLIC COMMENT:**

Members of the public shall have an opportunity to address the City Council regarding matters on this Agenda. Speakers should limit their comments to three (3) minutes.

Public Comment was opened.

City Attorney Hilda Montoy Cantu advised Mayor Garcia and the Council that this is a different type of special meeting. The process for this meeting is that the candidates are called in order and public comment follows. Ms. Montoy Cantu stated the City Clerk will give a report, Council will then have the presentations and then public comment.

#### A. PETITIONS, BIDS, RESOLUTIONS, ORDINANCES, AND AGREEMENTS

#### A-1 City Council Appointment to Fill Vacancy in Council District 5

Recommendation: Consider the Applications for the City Council District 5 Seat and after selection adopt a Resolution making appointments to fill the vacancy or direct staff to bring a Resolution calling a special election to a special meeting set by the City Council no later than January 31, 2021 (Report by

Alicia Gonzales)

Candidate Christopher Mariscotti addressed the Council and responded to questions.

No Public Comment was submitted for Mr. Mariscotti.

Candidate Elsa Mejia addressed the Council and responded to questions.

Veronica Rodriguez, Ramon Lopez-Maciel, Cindy Barragan, Edgar Garcia, Patsy Mejia, Jessica Flores, Daniela (no last name mentioned), Treyon Cummings, Ervin Reyes, and Johanna Torres each submitted a statement of their support for Elsa Mejia for the District 5 Councilmember position.

Candidate Matilda Villafan addressed the Council and responded to questions.

Cynthia Wilson stated her support for Matilda Villafan for the District 5 Councilmember position.

A petition with 167 signatures was submitted in support of Matilda Villafan for the District 5 Councilmember position.

Courtney Gutierrez submitted a comment sharing her disgust with the questions asked by Mayor Garcia which zeroed in on two of his favorite political initiatives which could be considered a violation of the Brown Act as a sub-meeting. She stated it is an abuse of a City Council seat and doing an absolute disservice to further his own agenda. She stated that because of this, the entire interview process needed to be re-done as this was conducted outside of lawful proceedings while indicating that he is a proponent for these items; it stunted the answers of the candidates.

Mayor Garcia asked Ms. Cantu Montoy to remark on the last public comment.

Ms. Cantu Montoy stated it was the person's right to have that opinion and perspective. Ms. Cantu Montoy stated that in her perspective, it did not violate the Brown Act.

No further public comment was submitted. Public Comment was closed.

Ms. Cantu Montoy stated that Councilmembers can express their viewpoints on who they like that way voters will know.

Councilmember Rodriguez stated he thought the voters in the district should make the decision on who should represent them.

Mayor Garcia asked Ms. Cantu Montoy to clarify the position of having to make a decision by the end of the month.

Ms. Cantu Montoy stated that under State law, the City is given 60 (sixty) days to either make an appointment to fill the vacancy for the unexpired term or to call an election. That decision must be made 60 (sixty) days from the date the vacancy became effective. If they don't decide on an applicant tonight, then it is important that they schedule a Special Meeting to call a Special Election, so they have very little time.

Mayor Garcia asked and City Manager Mr. Rodriguez responded that a Special Election would cost approximately \$15,000 to \$20,000.

Applicant Christopher Mariscotti addressed the Council stating, after listening to the other two candidates for this position, and all the things that were a concern to the other Councilmembers, he believes that both the candidates would do a better job than he would. Mr. Mariscotti withdrew from the appointment process at 7:00 p.m.
