Khalid Chaudry asked what HdL is charging for. City Manager Arnoldo Rodriguez stated the HdL fee is \$59,000 for reviewing applications. Some applications will take more time to review. The application fee is approximately \$10,500 per application.

Rico Saldivar who was representing a potential future cannabis business asked that Council reconsider the number of permits and licenses and even them out from 6 and 2 into 4 and 4.

City of Madera 205 W. 4th Street Madera, CA 93637 Khalid Chaudry asked why there are 150 questions on the application. He stated he didn't understand the HdL fee as they are just reviewing and pushing paper.

George Deleija who was representing a potential future cannabis business stated he would like to see more representation of minorities and people of color. He would like the number of permits and licenses to change to have both be even numbers.

Roman Gonzales stated he is looking forward to growing and revitalizing the downtown area. He is excited that they are going to move forward with this item today. They want to keep the sales dollars here.
