August 16, 2022, 3:30 p.m.

A regular meeting of the Madera ADA Advisory Council was scheduled for 3:30 p.m. on Tuesday, August 16, 2022. The meeting was held in-person in the City Hall Council Chambers and via teleconference.

Chairperson DJ Becker called the meeting to order at 3:33 p.m.

### Public Comment:

Alicas Conley from The Arc Fresno/Madera Counties shared a brief presentation about what their agency does and the importance of adult changing tables. The Arc offers adult day programs, community-based employment, behavioral services, leadership programs and community living. One of their goals is to make facilities and day-to-day activities accessible to everyone. One way they would like to do that is by increasing the number of adult changing tables in CA. As of now, there are only 12 adult changing tables in all the airports in the United States. Felipe Lemus also spoke to the importance of changing tables in CA. President Tyrone Cobb from The Arc Fresno/Madera Counties ended the presentation by speaking about how he has been adversely impacted due to the lack of adult changing tables.

#### **Business Matters**

- 1. Approval of Minutes Meeting of August 16, 2022. Councilmember Tim Riche moved to approve the minutes; motion seconded by Councilmember Diana Robbins. All councilmembers voted yes to approve the minutes. Motion passed unanimously.
- 2. Discussion regarding participation in 2022 Madera Old Timers Parade and Booths in the Park. The parade is on Saturday, September 24, 2022, at 10:00 a.m. and concludes at noon. It costs \$45.00 to enter. Booths in the Park costs \$40.00 to participate, but it requires staffing to set up and tear down the booth. Staff would need to be present from 8:00 a.m. to 3:00 p.m. Councilmember Ortegón said she could staff the booth following the parade. Chairperson Becker texted Councilmember Smith during the meeting to ask if he volunteer his vehicle for the parade. Councilmember Smith replied and said yes. Chairperson Becker said she would likely staff the booth. Councilmember Mohammad, President of Madera Young Professionals, said applications and fees are due by September 2, 2022. According to Councilmember Mohammad, vendors must set up their booths by 8:00 a.m., but the event will begin at 10:00 a.m. At the conclusion of discussion, the ADA Advisory Council confirmed participation in the parade but will not be staffing a booth.
- 3. Fiscal Year 2022/23 Budget Expenditures
  - a. Disability Awareness- Save the Space Campaign for October 2022. In the past, the ADA has printed out save the space signs and flyers. The Madera Police Department collaborated with the ADA in the past and posted the campaign to their Facebook page. The ADA will pay for the boosted Facebook ad.
  - b. Community Outreach Events- \$45.00 of the budget will be used to participate in the parade. Wendy Silva reported that there is a box of ADA coloring books left. If the ADA decides to print trifolds, that cost will be nominal.
  - c. Give-aways- Chairperson Becker would like to purchase an additional 25 flags. Wendy said the ADA can purchase giveaway items such as bracelets depending on the events the ADA decides to participate in.

After discussion of the above potential expenses, Wendy summarized the proposed ADA budget expenditures for Fiscal Year 2022-23 will be

- \$40 for the parade entry
- Approximately \$200 for flags
- \$50 on various items to print
- \$500 on Save the Space campaign
- \$200 for miscellaneous expenses or additional items in the Spring.

Diana Robbins made a motion to approve the ADA budget as described; motion seconded by Councilmember Ortegón. All councilmembers voted to approve the budget except for Mr. Latif due to audio connectivity issues.

- 4. Update on ADA Self-Evaluation and Transportation Plan Project- Wendy Silva reported that she met with them new induvial assigned to the ADA self-evaluation. Wendy highlighted missing portions of the contracted scope of work, and they will be working on providing a good quality report. The facility and right-of-way survey is also pending.
