Staff provided Council with an update on projected revenues for Fiscal Year Budget 2021-2022. This Item was informational only and required no specific action by Council.

Staff sought direction on trainings previously requested by Councilmembers. Hilda Cantu-Montoy City Attorney offered the following trainings for Council to consider: City Council Legal Powers & Obligations, Open Government and Conflicts of Interest, Governance and Success, Procedure for City Council Meetings, Land Use 101, CEQA Refresher, Public Hearings, and Relationship between Council, Manager and Staff.

Staff sought direction from Council on beginning a process to explore opportunities for civic engagement. The goal is to involve community members and offer a "Citizens Academy" in which residents can learn about the different aspects of local government. Suggestions for the informational sessions were City Governance for the Public, Citizens' Role in Meetings/Hearings, Public Engagement, Written Rules and Procedures for City Council Meetings and Events Policies and Protocols.

On the first item, Council would like to cover any and all trainings listed as time permits.

On the second item, Council expressed their approval in offering a Citizen's Academy for any residents who are interested in accessing the different governmental resources available to them.

E-3 Appointment of a 3rd Councilmember to Ad-Hoc Committee to participate in negotiations on a tax sharing agreement between the City and the County

At the May 4, 2022 Council meeting, two Councilmembers were elected to serve on an Ad-Hoc Committee to negotiate tax sharing agreement with the County, with the possibility of adding an additional member pending agreement from the County. After the meeting, staff approached the County on the subject, and the County confirmed that it is agreeable with the additional appointment to the Committee.

F. COUNCILMEMBER REPORTS/ANNOUNCEMENTS/FUTURE AGENDA ITEMS:

This portion of the meeting is reserved for the Mayor and Councilmembers (i) to make brief reports on boards, committees, and other public agencies, and at public events, (ii) to request updates, (iii) to initiate future agenda items., and (iv) to take action on matters initiated under this section of the agenda. Under this section the Council may take action only on items specifically agendized and which meet other requirements for action.

Councilwoman Gallegos expressed her gratitude to Staff, police officers and firefighters who were present at the Riverview fire. Miracle Realty has set up a GoFundMe for both families affected by this fire.

Councilmember Montes voiced his sympathies to the families who lost their homes to the Riverview fire, and commended Fire and PD for their efforts. He also highlighted AB-1482 regarding rent protection and asked to involve all interested parties in the discussion in future meetings. He mentioned concerns on behalf of the Soccer Leagues of Madera which he would like to bring on the record at a future meeting.

Councilmember Rodriguez reviewed his meeting with Madera County Transportation Commission Steering Committee and their efforts to pass Measure T, which will provide funding that allows for road repairs. He also mentioned the "Walk the Trails" event at Town & Country Park and expressed his appreciation to Joseph Hebert and the PCS team for pursuing the funding and for executing this project. He expressed his sympathies to the families who were tragically affected by the Riverview Fires and thanked fire fighters and police officer who were there protecting the community. Lastly, Councilmember Rodriguez confirmed that the City and its partners have secured enough funding to finance a fireworks show for the public to enjoy for the 4th of July celebration.

Mayor Pro Tem Evans acknowledged Joseph Hebert and the Parks Staff for coordinating the reopening of the Frank Bergon Senior Center. She also highlighted the Madera County Law Enforcement Memorial Ceremony held on May 17th honoring local Madera County peace officers who gave their lives protecting our community. She also thanked Staff and first responders for their help covering the Riverview fire.

Councilwoman Mejia had nothing to report.

Councilmember Villegas conveyed his sympathies to the families who lost their homes and thanked the fire department and surrounding area responders for their responsiveness in the Riverview fire.

Mayor Garcia recognized citizens in attendance for voicing their frustrations and concerns and thanked the City Manager for securing an emergency verbal approval from the California Department of Fish and Wildlife to clean up the Fresno River.
