DJ Becker spoke on illegal fireworks and asked Council to be proactive in updating essential ordinances.

Cynthia Ortegon thanked Interim Director of Public Works Dan Foss for his service.

Carmina Rodriguez spoke on blood donation and asked that citizens be informed through the City of Madera newsletter of the importance of blood donations.

Fire Division Chief Matt Watson gave a quick update on the Fresno River clean up. He stated that in addition to the Madera Irrigation District (MID) crews, City of Madera Public Works crews, City of Madera Parks and Community Services crews, and City of Madera Fire Department crews; CalFire fire fighter hand crews did about 680 hours' worth of work. He thanked City of Madera Public Works crews for providing the bathrooms; the City of Madera Parks and Community Services Department for chipping branches and Fire Station 58 for providing the logistical needs for those crews.

Fire Division Chief Matt Watson stated that the 4<sup>th</sup> of July was a very busy night for the City Fire Department. There were 52 total incidents within the City of Madera. City Fire Department responded to 24 fires within the City. Madera County Fire Department responded to 12 fires within the City. There were 14 additional calls for service and the City responded for the County with 3 additional fires. There were times where they couldn't respond to number of emergencies coming in. They staffed two additional engines for that night, but it still wasn't enough. The City helped County and County helped the City so they were able to cover those fires closely.

Fire Division Chief Matt Watson stated that the Madera Police Department had 20 additional officers on duty that night. There were 21 arrests and/or citations that night.

Councilmember Rodriguez mentioned that he attended the 4<sup>th</sup> of July Golf Tournament and praised the Parks and Community Services Department for hosting the event. He stated his team placed 3<sup>rd</sup> in the competition. He urged Staff and the public to attend next year. Councilmember Rodriguez asked for guidance from the Police Department regarding the strains that could arise on Police Department staff if a potential Fireworks Ordinance were put into effect regarding illegal fireworks.

Councilmember Montes praised City Staff for their efforts in responding to resident concerns.

Mayor Pro Tem Evans acknowledged her colleagues and City Staff for being pleasant and cooperative to work with. She reiterated her appreciation for those who are working in the Fresno River Cleanup Project.

Councilmember Mejia mentioned she and Councilmember Montes attended the Madera Soccer League's recent tournament in support of local teams.

Councilmember Villegas announced that the Madera County Art Authority has approved a logo as MCAA and will have signage for their future building. They are currently considering sites for their new location.
