On an annual basis, the City of Madera receives Community Development Block Grant (CDBG) program funds from the U.S. Department of Housing and Urban Development (HUD). The purpose of CDBG funds is to develop viable communities through providing decent affordable housing, a suitable living environment, and expanded economic development opportunities for persons of low and moderate-income.
