Chairperson DJ Becker called the meeting to order at 3:34 p.m.

# Public Comment:

The Transportation Engineer/District ADA Coordinator at Caltrans, Victor Aldama, introduced himself to the ADA Council. He graduated from Fresno State and was an Engineer at the City of Madera for a little over 4 years. Mr. Aldama extended his support to the Advisory Council and said he is looking forward to collaborating.

# **Business Matters**

- 1. Approval of Minutes Meeting of January 17, 2023. Councilmember Saim Mohammad moved to approve the minutes as presented; motion seconded by Councilmember Diana Robbins. All councilmembers in attendance voted yes to approve the minutes.
- 2. Discussion of accessibility concerns regarding Yosemite Manor apartment complex-Chairperson DJ Becker said she received a call from an 89-year-old resident at Yosemite Manor and was told both elevators were inoperable. The resident had no choice but to use the stairs to leave the building. The resident also said their disabled friends who reside in the second and third floors were at home for a week without access to leave for appointments. According to

Chairperson Becker, the Fire Department was unaware of the issues and allegedly, the elevators did not have a maintenance schedule.

Wendy Silva reported information received from Mr. Lewis, MORE's Legal Counsel, via email. MORE's is the owner of Yosemite Manor. The Housing Authority had been acting as a property manager at Yosemite Manor until December 15, 2022. Mr. Lewis said they were looking for a new property manager because maintenance issues were not being addressed. According to Mr. Lewis, the Housing Authority left the property on December 15, 2022, without notice. It took about two weeks to get a new property management company in place. FPI is the new management company, which is a tax credit property management company for affordable housing. At the time FPI took over, they did not have access to computers or keys. According to Mr. Lewis, one of the elevators was historically problematic and not fixed, and FPI immediately began working on that one when the second elevator failed while parts were in transit. Both elevators were ultimately repaired, and MORE's is currently looking into purchasing a stair climbing emergency wheelchair system for Yosemite Manor.

Based on information provided by the Madera City Fire Chief, Ms. Silva advised that the Fire Department did offer to safely help residents down the stair's multiple times a day while the elevators were out of order. Chairperson Becker commented that it was a tarp sling with handles. Ms. Silva also clarified for the record that Yosemite Manor is designated for seniors 55 years of age and up, but it is not assisted living.

Chairperson Becker asked if the City has responsibility to inspect Yosemite Manor. Ms. Silva responded and said the only reason the City would enter an occupied building is if there was active remodeling or if the building had code enforcement violations such as mold or leaking water. From the discussion Ms. Silva had with Mr. Lewis, it seems they are trying to give FPI the opportunity to address deficiencies at Yosemite Manor. MORE's also recognizes there is a long list of applicants waiting to get senior housing even when Yosemite Manor had vacancies. This is an issue MORE's wants to get resolved and hopes FPI can bridge that gap. Chairperson Becker said the ADA Advisory Council has always advocated for safe housing for seniors and disabled residents.

- 3. Discussion regarding support for teleconferencing options to be included in the Ralph M. Brown Act for meeting participation- Wendy Silva said the Brown Act was relaxed during COVID which allowed for teleconferencing. Public meetings on Zoom were acceptable if the meeting was accessible to all and if roll call votes were taken. The Brown Act does not prohibit the public or staff to attend via Zoom but requires voting members to attend in person or follow rigid guidelines to participate via Zoom. Chairperson Becker wants to draft a letter to the Brown Act committees on behalf of the City of Madera ADA Advisory Council. Allowing voting members to attend public meetings via Zoom would benefit the disabled community and would minimize the lack of quorums. Majority support to submit a letter was confirmed. Chairperson Becker will work on drafting a letter.
- 4. Disability accommodation regulations for federal buildings- Vice Chairperson Ortegón had asked for staff to provide information on disability accommodation regulations that apply to federal buildings such as the Madera Post Office. The Post Office predates both the Architectural Barriers Act of 1968 and the Americans with Disabilities Act. Additionally, the Americans with Disabilities Act does not apply to buildings like post offices. For context, the Post Office views requests such as counter height adjustments as discretionary items per their

code of regulations. It is solely at the discretion of the local postmaster who must get the approval of the area manager. If the ADA Advisory Council desires change at the Madera Post Office related to disability accommodations, the Advisory Council can write to politicians who may be able to encourage the postal service to make the doors and counter height ADA accessible. Lastly, the ADA Council wants to get driver side mail drop boxes.

5. Advisory Council Reports/Announcements/Requests for Future Agenda Items

Chairperson Becker reported on the new benches at the Walmart in Madera. The benches are on the inside near the exit door and pictures were shown of the benches. The outside section near the buses still needs benches, but Walmart is showing progress.

Councilmember Gladys Marroquin reported the area of Central and 4<sup>th</sup> has wheelchair accessibility issues. She observed a person in a wheelchair that required assistance to pass through the area. Wendy Silva said this issue will be addressed in the ADA Self-Evaluation and Transition Plan. Councilmember Marroquin also said it is an unsafe area for children to cross because she has witnessed children running through the crosswalk to avoid erratic drivers. The ADA Council concluded that any traffic concerns and unsafe driving should be reported to the Madera Police Department.
