#### SUBJECT:

Accepting a Portion of the Improvements for the Iveywood I Subdivision

#### **RECOMMENDATION:**

Adopt a resolution:

- 1. Accept a portion of the improvements for the Iveywood I Subdivision
- 2. Authorize the filing of the Notice of Acceptance for said subdivision improvements

#### **SUMMARY:**

The Subdivider, Joseph Crown Construction and Development, a California Corporation (Subdivider), has completed the off-site public improvements in accordance with the approved Improvement Agreement (Agreement) and improvement plans. The Subdivider has paid all required fees and submitted a warranty bond for the completed improvements. It is recommended that the City Council (Council) accept that portion of the improvements completed for the Iveywood I subdivision.

#### **DISCUSSION:**

The Iveywood I subdivision is a residential development located on the northwest quadrant of Sunrise Avenue and Tozer Street. The Council approved the Final Map on February 17, 2021. An amendment to the Agreement was approved by Council on November 16, 2022, to incorporate park improvements in the Agreement for future reimbursement. The Subdivider has completed a portion of the public improvements in accordance with the approved Agreement and improvement plans. Approval of the resolution will cause acceptance of specific improvements listed below as defined by the Agreement:

#### 1. Tozer Street Construction:

- Approximately 1,574 linear feet of north and south travel lanes (22 feet in width total per the Agreement), located immediately adjacent (east and west) to the center 16 feet of the arterial roadway.
- Approximately 277 feet of the center three lanes (including median) of this street construction (40 feet in width).

#### 2. Storm Drain Main Construction:

 Approximately 265 linear feet of 54-inch pipeline, 942 linear feet of 24-inch pipeline and 42 linear feet of 18-inch pipeline

It is appropriate for the City to accept the completed improvements as the previously mentioned improvements have been installed in accordance with City Specifications and conform to current City Standards. Acceptance of a portion of the public improvements required of the Subdivider is permitted per Section 10-2.712.3 of the Madera Municipal Code. The Subdivider has yet to request final acceptance of other eligible improvements, primarily a storm drainage basin and construction of a parallel sanitary sewer main in Pecan Avenue, for reimbursement as described within the Agreement. The Subdivider has previously paid all required fees and provided payment and performance bonds sufficient to cover uncompleted work.

#### **FINANCIAL IMPACT:**

Acceptance of this subdivision will result in the transfer of maintenance and resulting costs from the Subdivider to the City.

#### **ALTERNATIVES:**

Should the City not accept the completed improvements, the developer will be required to wait until all exterior improvements are completed to make a request for acceptance of all improvements.

**WHEREAS,** that portion of improvements consists primarily of street and storm drainage improvements along Tozer Street; and

- 2. The subdivider has completed a portion of improvements for Iveywood I Subdivision, within the following right-of way:
  - a. Tozer Street All street and storm drainage improvements between Sunrise and the northerly limits of the subdivision.
- 3. The City Clerk is hereby authorized and directed to record a Notice of Partial Acceptance as required by Section 10-2.712.2 of the Madera Municipal Code.
