# E-2 Informational Report Regarding Senate Bill 227

Deputy City Clerk Zelda León provided Spanish translation for those in attendance and English translation of the public's comments to Council.

Pedro (no last name given) spoke in favor of SB 227 unemployment benefits for undocumented field workers. He said they deserve these benefits as they give a lot to this/his country (USA).

A community member spoke in favor of SB 227 and asked that this item be put onto the next Council agenda for action.

Rosa Hernandez of Oaxaca spoke in favor of SB 227. She is a field worker, and they are always affected during the months without work. They must ask others for loans. They were affected by COVID. They do not have savings or gas but they must continue to live. Without money, they do not have food or money for rent. It is sad for them. She said there are a lot of undocumented people in Madera.

Ervia Dominguez spoke in favor of SB 227. She has lived in Madera for 22 years. She works in the fields and has always done her taxes without fail and has never gotten any unemployment benefits due to her immigration status. She stated that COVID and rains have made for difficult

times. She has at times been without work for a month and it is difficult economically for rent and utilities especially as a single mother. She asked that Council support SB 227 so they can get these unemployment benefits as it would be a fundamental help to all families.

City Attorney Hilda Cantu Montoy advised Council that the way the item is worded on the agenda, they are unable to take action or give direction to staff. She stated, if Council decided, that those in attendance could give public comment but if it became very repetitive, Council could ask those in attendance had anything different to add. Then afterwards, Council could ask to see how many in attendance were in support of the item. Councils take this approach, so that people don't have to come back and give public comment at the next Council meeting as the report would mention the number of people who spoke in favor of Council supporting the measure.

Serai Martinez, Executive Director of Centro Binacional Para El Desarollo Indigina spoke in favor of SB 227. She asked for those in attendance to stand to show who was in support of this item. City Clerk Alicia Gonzales counted 38 people who stood. Ms. Martinez stated that SB 227 would provide a safety net for undocumented workers. She said they are advocating for this law and need Madera leaders to be their voice at the state level. She stated that New York has this law and Colorado passed it last year.

A community member spoke in favor of SB 227. She stated that it took courage for all the individuals in attendance to be there that day. They contribute to the fund and it would be nice for them to have the bare minimum.

No further public comment was presented. Public Comment was closed.
