Councilmember Gallegos requested additional information on criteria for Educator of the Year. She expressed appreciation to Assemblywoman Esmeralda Soria, who has advocated strongly for Madera Community Hospital (MCH) and helped in the passage of new legislation which will provide financial assistance to struggling hospitals in California. She thanked City staff and departments for their support and sharing their condolences for the passing of her mother.

Councilmember Montes attended the Relay for Life event and presented a City Council Recognition for the work they do in spreading awareness for cancer-related research and funding.

Councilmember Rodriguez requested clarification on rules and procedures for Council regarding the matter of motions.

Councilmember Evans attended the Law Enforcement Memorial Ceremony hosted by Madera County, in which attendees paid tribute to those who lost their lives in the line of duty. She also expressed her appreciation for Assemblywoman Soria for visiting MCH, speaking with constituents and working purposefully to request relief funding for the Hospital. She attended a community survey and presentation regarding MCH and its impacts on the community. The Domingo Velasco Soccer League honored Mayor Pro Tem Mejia and Councilmember Montes for their service to their community. She mentioned the Planet Fitness kick-off party, in which the gym is offering discounts to young athletes in Madera.

Councilmember Villegas mentioned the Arts Fest hosted by Madera County Superintendent of Schools and thanked Senator Anna Caballero and Assemblywoman Soria for their help in advancing legislation to help financially stressed hospitals.

Mayor Garcia visited a 1st grade class at Pershing Elementary and participated in a Q&A session with students. He highlighted Shirley James of the Madera Tribune, who celebrated 40 years of service with the newspaper. He presented Ms. James with a Mayor's certificate for her decades of service to the community. He also mentioned Planet Fitness and its summer passes for high school students. Mayor Garcia attended the annual Prayer Breakfast and the Veterans of Foreign Wars events. He addressed Senate Bill 112 and said it is a step in the right direction in terms of opening Madera Community Hospital; however, he reminded the public that the process could be long and arduous. He mentioned the Memorial Day celebration on Monday, May 29, 2023 at Courthouse Park.
