Chairperson Porter called the meeting to order at 3:30pm.

No public comment.

Business Matters

Approval of Minutes – Meeting of March 18, 2025. Councilmember Robbins made a
motion to approve the minutes as presented; motion seconded by Councilmember
Munyaradzi. All council members voted yes to approve the minutes. Motion passed
unanimously.

- 2. Discussion of City of Madera Housing Authority accessible and affordable housing options and needs was presented by Executive Director Blanca Mendoza-Navarro. She offered the agency's portfolio data concerning public housing and ADA accessibility. Currently there are 244 units of public housing, in which 11 of those are ADA accessible. There are 100 units of farm labor housing and 3 of them are ADA accessible. The Housing Authority also manages a Housing Choice Voucher Program, which include 804 vouchers for affordable housing needs. A partnership with the management company of Arbor Pointe and Esperanza Village have taken place, currently accommodating for 16 units and 1 is a fully accessible ADA unit at Arbor Pointe and 30 units at Esperanza Village with 2 ADA units accessible. Vice Chairperson Ortegón and Director Mendoza-Navarro discussed the HUD requirements of 5 percent housing availability for ADA and the notion that housing may be grandfathered-in based on year built. As each housing project undergoes rehab or renovations, they must support ADA guidelines. Chairperson Porter and Director Mendoza-Navarro further discussed the possibilities for renovations or reasonable accommodation for those that may need ADA accessibility, when there is no current ADA unit availability. When such instances occur, those families that were previously placed in an ADA unit sign a waiver at the beginning of their tenancy stating possible relocation based on the needs of an ADA family. Director Mendoza-Navarro did not have further information for those families that hold a Housing Voucher (Section 8) that require ADA accessibility, whereas the property owners or management companies housing those families would have that data available.
- 3. Enforcement of accessible parking regulations and accessible parking stall compliance was presented by Sergeant Brent Cederquist. He confirmed that the Madera Police Department does actively enforce accessible parking regulations and issues citations related to 22507.8 of the California Vehicle Code. It is a part of the officer's daily assignments to check high traffic zones, such as Walmart and Lowes parking lot areas. Chairperson Porter had specific concerns about tickets not being issued, and inquired about officers asking questions as to why they are illegally parked in a reserved handicap parking space instead of ticketing for the violation. Sgt. Cederquist suggested that if officers are not following general practice, that a supervisor be contacted to address the concerns. Chairperson Porter led the discussion into ride-a-long opportunities for the general public. Councilmember Munyaradzi inquired if a vest would be available for the passengers. Sqt. Cederquist confirmed that ride-a-longs and vests area all available upon request, both weekdays and weekends and offered his contact information. He discussed further that concerns regarding proper display of accessible disabled stalls on private property or private businesses can be best handled through code enforcement. Vice Chairperson Ortegón suggested the officers offer education to the violators in addition to the citation.
- 4. Discussion of Madera County Transportation Commission Unmet Transit Needs Report was shared by Vice Chairperson Ortegón. Every year in April, Madera County Transportation Commission completes an unmet needs evaluation for the people who live in the City and County, referencing transportation. Vice Chairperson Ortegón has attended and represented the ADA for the past 20 years, offering

updates and information being requested. Meetings surround discussion involving the public's unmet needs, their feasibility, cost effectiveness, etc. For 2025, on unmet need mentioned was transit service from Chowchilla to UC Merced and Merced College. There is not enough documentation of demand for a route to Merced and Amtrak currently offers services to Madera and Merced. Another unmet need stated was additional frequency on the Valley Children's Route, requesting for more buses, more often. Although it was not found as a reasonable unmet need now, it may be in future with the expansion of the area. The suggestion of increasing the times of bus services to early morning or late pm hours was discussed. There was not enough ridership to justify that notion as an unmet need. Another unmet need brought up was routes to Camarena from La Vina. It was stated that while the City's Madera Metro system does have Dial-A-Ride or Handy Ride available to help facilitate those needs for Madera County Residents, travel from Madera Acres to Children's Hospital does not have enough ridership to facilitate the request. Councilmember Munyaradzi suggested that during the Madera County Transportation Commission study of unmet needs, it would be helpful to offer a balanced perspective of the enterprise to declare whether the "unmet needs" currently exist or have been achieved. Vice Chairperson Ortegón shared that there is a new head of Madera Transit Center (MTC), and he is very proactive, offering a smaller, more legible map of the routes and schedules of the transportation system in real time. MTC is also actively working on a micro transit system to fill in the gaps for the needs of public riders. Discussions ensued of Madera Transit Advisory Board (TAB) to hire a consultant to perform a study on micro transit.

- 5. Discussion of standard meeting frequency was brought forth by Chairperson Porter. This past year, ADA experienced a period of 5 months without holding a meeting due to lack of quorum or lack of business items for discussion. Chairperson Porter suggested meeting every 3 months, or quarterly, (similar to TAB), asking Director of Human Resources Wendy Silva if there was a requirement of a monthly meeting. City of Madera is a general law city but do adhere to current bylaws that indicate ADA to meet monthly. Those bylaws can be amended with a request to City Council with a potential to meet quarterly, voting meetings can also be called by the chair if a situation requires a more frequent meeting, such as emergency meetings, etc. Suggested meeting in June and have a potential to bring to Council in July and met quarterly thereafter. This agenda item was continued to June at the request of Vice Chairperson Ortegón.
- 6. Advisory Councilmember Reports: Vice Chairperson Ortegón announced an upcoming event, the Pride Parade on May 31st being held at Hatfield Hall in Madera (2nd Annual), and Pride Parade on June 7th at the Tower District in Fresno.
