



NOTICE OF PUBLIC COMMENT PERIOD



CONSOLIDATED ANNUAL PERFORMANCE EVALUATION REPORT PROGRAM YEAR 2024-2025

The City of Madera is soliciting public review and comment on the Consolidated Annual Performance and Evaluation Report (CAPER) prepared for the 2024-2025 Program Year. The CAPER is submitted annually to the U.S. Department of Housing and Urban Development (HUD). It describes the City's use of federal Community Development Block Grant funds for the period of July 1, 2024, to June 30, 2025.

A public review period for the CAPER begins August 30, 2025, at which time the City will make available a Draft of the 2024-2025 CAPER for a 15-day review and comment period at www.madera.gov. The City of Madera must receive all comments on the CAPER by 5:00 p.m., September 15, 2025, in order to be included in the report submitted to HUD.
